As of February 16, 2015, the SAFE MLO National Test is administered using Linear on the Fly Testing (LOFT). This allows for a distinct form of the test to be given to each test taker. Since the difficulty of each form varies slightly, the candidate's test is statistically equated to a standard form of the test.
