So-called "nuisance" diseases, such as scabies, head lice (pediculosis), ringworm of the body or scalp, and pinworms are highly contagious and can cause problems in a group-care setting. Children and adults with these conditions (except ringworm of the body and pinworms) should be excluded until treated.
