COMPLETING THE MONTHLY EMPLOYER DECLARATION (EMP201) The amounts deducted or withheld by you, the employer, must be paid to SARS on a monthly basis by completing the EMP201. You need to submit your EMP201 and the payment, if applicable, within 7 days after the end of each month, e.g. by the 7th of each month.

Information to complete the declaration, is available from your payroll company by printing the EMP201 report. Complying with EMP201 and EMP501 submissions without using ...

The EMP501 serves as a reconciliation done by the employer. This reconciliation is between the EMP201 (monthly) returns and the information that SARS has in terms of payments. For smaller firms (less than 50 employees) there are 2 ways of submitting this reconciliation: SARS eFiling; SARS E@syfile (the only option for more than 50 employees)

EMP501: What is it and how does it impact employees?

We recommend registering for eFiling or using the application, both available from the SARS website, to submit your EMP201s. PAYE, SDL, UIF and ETI Breakdowns When clicking on the web version of your EMP201, you will see the details of your EMP201, including PAYE, SDL, UIF and ETI.
