The Government has fixed the time-limit of 45 days for registration of Trade Union under the Trade Unions Act, 1926 , vide its Order dated 02.05.2017.

LABOUR LAWS IN INDIA

Article 23 prohibits all trafficking and forced labour, while article 24 prohibits child labour under 14 years old in a factory, mine or "any other hazardous employment". Articles 38-39, and 41-43A, however, like all rights listed in Part IV of the Constitution are not enforceable by courts, rather than creating an aspirational "duty of the State to apply these principles in making laws".
